# **Executive Summary**

The purpose of this Public Participation Plan (PPP) is to formally document community concerns regarding a site or facility and to identify specific public participation activities that will be implemented to ensure the community is involved in the DTSC decision-making process. This Public Participation Plan has been prepared by the California Department of Toxic Substances Control (DTSC) to describe all activities undertaken or planned to inform and involve the community during investigation and clean-up of the Georgia-Pacific site (Site) in Fort Bragg, California. This plan also includes a description of the Georgia-Pacific site and relevant background information, a description of the surrounding community and a summary of their issues and concerns, and an outline of specific public participation activities to be conducted during the investigation and clean-up process.

#### Site Location

The Site is located along the coastline in the City of Fort Bragg, 90 West Redwood Avenue, Fort Bragg, California, 95437, in Mendocino County. Located on approximately 415 acres west of Highway One, the Site is bounded to the south by Noyo Bay, to the west and northwest by open Pacific Ocean coastline, and to the northeast and east by the City of Fort Bragg.

#### Regulatory Involvement

DTSC will provide regulatory oversight for the investigation and clean-up activities and will coordinate the input and involvement of other agencies. Georgia-Pacific will perform such investigation and cleanup activities and reimburse DTSC for costs related to its oversight.

#### **Community Concerns**

Over 13,000 Community Surveys were mailed to the communities around the Georgia-Pacific site, with 1,029 completed and returned. In addition, 36 community members were interviewed to obtain a sample of the community's views. Community members generally seemed confident with DTSC's ability to manage the site cleanup process. Most concerns were related to the reuse of the property once the environmental cleanup was complete, followed closely by the potential human health and environmental impacts of contamination on the site.

#### **Recommended Public Participation Activities**

DTSC has included a number of public participation activities in this PPP intended to continue its goal of ensuring that the local community is informed about the site investigation and cleanup activities and given an opportunity to ask questions about clean up and reuse activities that will be occurring at the Georgia-Pacific site. Some of these activities are: providing fact sheets to the community during key milestones; keeping public documents available for public review in the information repository; providing public meetings and workshops, as necessary; and advertising public comment periods in local news sources.

# **1.0 INTRODUCTION**

This Public Participation Plan (Plan) has been prepared by the California Department of Toxic Substances Control (DTSC) to describe all activities undertaken or planned to inform and involve the public and all stakeholders associated with the investigation and cleanup of contamination at the former Georgia-Pacific Mill Site (Site) located at 90 West Redwood Avenue, Fort Bragg, California, 95437 in Mendocino County (see Figure 1, site location map on page 4). The Plan was prepared based upon the guidance presented in the DTSC Public Participation Manual. DTSC will use this Plan to identify any community concerns and issues, and to outline a strategy for keeping the public informed throughout the investigation and cleanup process.

#### **1.2 Sources of information used**

This Plan was developed with information gathered from community survey responses, interviews and demographic data available from the Internet.

#### 1.3 Agency with oversight responsibilities

The North Coast Regional Quality Control Board (NCRWQCB) was the lead agency within the California Environmental Protection Agency (Cal/EPA) charged with the oversight of the site investigation. However, new information obtained by

NCRWQCB, combined with data gathered over the past three years, led them to conclude that issues related to human health exposure need to be addressed at this site. The oversight Agency Selection Guidelines of the *Memorandum of Agreement on Oversight of Investigation and Cleanup Activities at Brownfield Sites* states that the Department of Toxic Substances Control (DTSC) should be the oversight agency if the primary concern is the risk posed to human health. Although the water quality issues remain, the NCRWQCB considered that the human health issues would be best addressed by DTSC. In July 2006, the NCRWQCB requested that the DTSC assume the role of lead oversight agency for the Georgia-Pacific mill site in Fort Bragg. The NCRWQCB will continue to participate in the review of materials to ensure protection of water quality and will provide input to the DTSC as the site investigation and cleanup continues.

# 2.0 FACILITY DESCRIPTION AND HISTORY

## 2.1 Site description, location, and surrounding land use

The Site is located along the coastline in the City of Fort Bragg, Mendocino County, California. Located on approximately 415 acres west of Highway One, the Site is bounded to the south by Noyo Bay, to the west and northwest by open Pacific Ocean coastline, and to the northeast and east by the City of Fort Bragg.

Adjacent to the mill site are a few residences to the north of the site along the fence line, the Glass Beach access road to the northwest, and various businesses along the eastern edge of the facility. The majority of the town of Fort Bragg is across Main Street/Highway 1 bordering the eastern edge of the Site. Most major public facilities such as hospitals, churches, and schools lie within ½ mile of the Site. Within the southernmost confines of the property is a small branch of the Pomo Native American community. In addition, there is a small sailor's cemetery.

Public access to the Site is prohibited. Security gates are located along the eastern fenced edge of the Site. Current site activities take place primarily in the northern half of the property, with a small amount of truck traffic along the main road from the southeast entrance.


Ongoing discussions continue to occur related to the proposed reuse of the Site once it is cleaned up. These discussions include a coastal trail, parkland, possible residential, etc. To date, no final decisions have been made regarding the reuse of the entire Site.


A site map (Figure 1) is presented on page 4.

# 2.2 Site history

The saw mill at Fort Bragg began operations in 1885. Georgia-Pacific acquired the site in 1973 and officially ceased operations in November 2002. During plant operation, logs were received by truck, unloaded, and stored in log-storage areas. Logs were then removed from inventory, debarked, and milled. Milled lumber was shipped green, kiln dried, or air-dried on site. Finished lumber was transported by rail or flatbed trailers. Bark and wood refuse were transported to the power plant by truck, conveyor, or pneumatic system where they were burned to generate steam for electricity.

The site expanded to its current size over the course of 117 years. Figure 2 on page 5 shows the location of major buildings, ponds, and other features. Figure 1 on page 4 shows the mill site in relation to the City of Fort Bragg.





# **3.0 SITE INVESTIGATION AND FINDINGS**

During previous investigations, the Site was divided into ten parcels based on historical operations and land use. The parcels are designated as follows:

Environmental documents related to Site investigations can be found on the NCRWQCB website (<u>www.swrcb.ca.gov</u>) and on the DTSC website (<u>www.dtsc.ca.gov</u>). To date, the extent of Chemicals of Potential Concern on the Site include (but are not limited to) the following:

- Total Petroleum Hydrocarbons Diesel (TPHd) in soil and groundwater samples, primarily in Parcels 3 through 6
- Metals (lead and antimony) in soil and groundwater samples, primarily in Parcels 3 through 6
- Polychlorinated biphenyls in a limited amount of soil samples, primarily in Parcels 3 through 6
- Polycyclic aromatic hydrocarbons, including benzo(a)anthracene, benzo(a)pyrene, benzene, and toluene in soil and groundwater
- Dioxin in soil, sediment, fly ash, and groundwater samples from locations related to the handling and management of fly ash resulting from boiler operations in the Powerhouse in Parcel 4. These locations include, but are not limited to, a soil and groundwater sample in Parcel 3, sediment samples underlying the North Pond, South Pond, and Ponds 6 through 8 in Parcel 4, sediment samples underlying Ponds 5 and 8 in Parcel 5, and fly ash stockpile samples and sediment samples underlying Ponds 1 through 4 in Parcel 7

# 4.0 PUBLIC INVOLVEMENT AND OUTREACH

# 4.1 Community background

Fort Bragg is a city in Mendocino County. In 1856, the Mendocino Indian Reservation was established at Noyo. It was 25,000 acres and extended from what is now Simpson Lane to Abalobadiah Creek and east to Bald Hill. A military post was established on the Mendocino Indian Reservation in 1857 and named after Captain Braxton Bragg, who later became a General. By 1867 the military outpost was abandoned and small lumber mills were being built in the nearby area. After the fort was evacuated, reservation land was offered for sale to settlers. In 1885, C.R. Johnson and partners moved their mill machinery from Mill Creek to Fort Bragg and incorporated as the Fort Bragg Redwood Company. In 1893 it was renamed the Union Lumber Company. The City of Fort Bragg was incorporated in 1889 with C.R. Johnson as its first mayor. In 1969 the Union Lumber Company was purchased by Boise Cascade and it, in turn, became Georgia-Pacific in 1973. In the wake of the declining lumber industry, tourism and commercial fishing became even more significant.

Commercial fishing played an important role in the formation of the economic base and history of the community. Noyo Bay, at the southern edge of Fort Bragg, provides a natural, convenient harbor, and fishermen began to land millions of pounds of salmon that were processed and marketed in Fort Bragg. Substantial salmon harvests continued in the Fort Bragg area until the mid 1990s. Despite the decline of the salmon industry, fishing remains a viable and important part of Fort Bragg's economy and community identity, and fishermen have developed alternative strategies to remain in the industry. Many boat owners offer private charter services for tourists and sport fishermen.

Lodging and hospitality services associated with Noyo Bay and coastal tourism are also revenue generators for the city. The rapidly developing tourist industry will help bolster and diversify the city's economy, which was greatly impacted by the closure of the Georgia-Pacific mill site. According to the 2000 Census, the population of Fort Bragg was 7,026. Estimated population for the year 2003 was 6,867—a decline of about 3%. The 2000 Census also indicates that 49.9% of the population were female, and 50.1% were male. The median age was in the 25-44 years bracket, and the average household income was \$28,539. Additional demographic information for the City of Fort Bragg is located in Appendix B of this Public Participation Plan.

# 4.2 History of community involvement

Several community meetings have been held to date:

08/02/2003 – an update on environmental investigations, held at the Dana Gray Elementary School

- 11/13/2003 an update on the progress of the Land Use Study, held at the Fort Bragg Town Hall
- 08/07/2006 an update on the status of ongoing environmental investigations, held at the Dana Gray Elementary School

Bus tours for the public were held on August 2, 2003, in conjunction with the meeting on November 13, 2003, and again on October 15, 2005 when the coastal trail was announced.

On September 12, 2006, DTSC's public participation program mailed a Community Survey to every address in the City of Fort Bragg and Westport (a total of 9,131 addresses) to assess the level of interest in the environmental cleanup activities at the Site. Respondents were asked to indicate whether they had any concerns about the Site and what those concerns might be, what the preferred method of information dissemination would be, whether they had contacted government officials about the environmental cleanup of the Site, etc.

In late September 2006, DTSC was requested to mail the Community Survey to outlying communities near the City of Fort Bragg. On October 2, 2006, the Survey was mailed to every address in the towns of Mendocino, Little River, Albion and Elk (a total of 4,086). This survey indicated that the recipients must request that their name/address remain on DTSC's mailing list for the Georgia-Pacific site or they would automatically be deleted and would no longer receive mailed information about the Site.

A total of 13,217 Community Surveys were mailed to the communities listed in the paragraph above. Of those, 1,029 completed surveys were returned to DTSC—a return rate of 8%. The mailing list was reduced to a current total of 8,771, based on undeliverable mail, those individuals who indicated they wanted their name removed from the mailing list, and those individuals who requested they remain on the mailing list. On an ongoing basis, DTSC will add names to the mailing list for those individuals who request it. An email list was also generated from the returned Community Surveys, consisting of 128 email addresses.

The Community Survey and survey results are located in Appendix D.

In November 2006, December 2006, and January 2007, DTSC representatives conducted telephone and in-person interviews with a total of 36 community members and public officials regarding the contamination and proposed remediation of the Georgia-Pacific site to learn more about community concerns.

In addition to the community involvement activities listed above, the local newspaper, *Fort Bragg Advocate News*, has published articles about the environmental cleanup of the Site. The local radio station KZYX has held segments on several aspects of the environmental cleanup of the Site.

# 4.3 Community concerns

The face-to-face and telephone interviewees basically reiterated the degree of understanding and concerns expressed in the community surveys, specifically:

- An awareness that logging industry activities can cause contamination to the soil, groundwater and possibly the ocean.
- The majority of the concern expressed related to properly cleaning up the property and how the property will eventually be redeveloped.
- Recent publicity about dioxin contamination on the property has raised a level of concern about possible health impacts; however, there is a high degree of confidence that the contamination will be properly cleaned up under the Department of Toxic Substances Control's oversight.
- Community members stated that they want contamination on the property to be "fully characterized" so all contaminants can be cleaned up. They want to be kept informed of contamination that is found on the property, and the cleanup plan and schedule.

# 4.4 Public participation strategy

Ongoing communication with environmental groups, community leaders and elected officials will be maintained in order to promote the dissemination of accurate and timely information, and to foster a positive relationship between community members, business owners, the City of Fort Bragg, Georgia-Pacific representatives, and DTSC.

The main objectives of the public participation strategy will be to:

- Keep the community informed as the project advances;
- Gather information from the community to help guide the project; and
- Adequately document and respond to community concerns and questions in a timely and proactive manner.

## 4.5 Implementation of public participation strategy

The public outreach strategy is designed to provide opportunities for the public to participate in the site investigation and cleanup process. Outreach will be developed based on information received from the community, and through communication with elected representatives and other community leaders.

At a minimum, as required by state and federal laws, the following public outreach activities will be undertaken:

#### Mailing list

A mailing list for the Georgia-Pacific project has been developed and will be maintained in the DTSC regional office in Sacramento, California. The mailing list includes local residents in the Fort Bragg, Westport, Mendocino, Albion, Little River, and Elk communities, businesses, city officials, and government agencies. The mailing list also includes individuals and organizations on DTSC's regional and statewide mailing lists. As of February 1, 2007, a total of 8,771 addresses are on the Georgia-Pacific mailing list.

The site mailing list will be used to notify interested individuals about sampling and cleanup activities at the Site and other off-site locations.

#### Public contact

The DTSC Project Manager and Public Participation Specialist will respond in a timely manner to inquiries from members of the public. Fact Sheets or Frequently Asked Questions informational documents may be generated to respond to issues that are raised by multiple community members.

#### Public comment period

As required by state and federal laws, DTSC will initiate public comment periods so the public can submit official comments on proposed draft cleanup documents, such as a Remedial Action Plan or a CEQA Initial Study.

#### Fact sheet

DTSC will oversee the preparation, distribution, and mailing of fact sheets at major milestones, and at the beginning of formal public comment periods. The fact sheets will be mailed to all individuals on the Site mailing list. The fact sheets will include names and contact numbers of the DTSC project team as well as the locations and telephone numbers for the information repositories where the cleanup documents may be found for public review. The fact sheets will be produced in English and Spanish, based upon a review of the community demographics (see Appendix B for the demographics).

#### Public notice

DTSC will oversee the preparation of a public notice that will be placed in the *Fort Bragg Advocate News*, and the *Mendocino Beacon*, based on the results of the Community Survey, on the start date of any public comment period for a proposed draft cleanup document (as required by state and federal laws), such

as a Remedial Action Plan or a CEQA Initial Study. Public notices will be produced in English and Spanish.

#### Work notice

DTSC will prepare and disseminate Work Notices when off-site sampling activities occur, and when removal activities are occurring that would potentially impact the community (i.e., trucks hauling soil away from the site, etc.). The Work Notices will be produced in English, with contact information to obtain Spanish translation. A sample Work Notice is included in Appendix C.

#### Information repositories

Information repositories have been established so that the public can access and comment on technical documents related to proposed cleanup activities. These documents will be available at the following locations:

Under Department of Toxic Substances Control (DTSC) oversight, sampling was conducted in those areas in late October 2006. Preliminary information indicates that some dioxin was found in the laboratory samples, but the number of samples collected were too small to establish the extent of dioxin contamination. Additional samples need to be collected to obtain an adequate set of data to make a formal evaluation. The additional sampling activities will occur toward the end of this week. The work is expected to be completed within two to three days. Because of the process necessary to test the samples for dioxins, we anticipate the results of the sampling event to be available in April 2007.

The purpose of this letter is to inform you that the Department of Toxic Substances Control (DTSC) has been named the lead agency for overseeing the investigation and any required cleanup of the Georgia Pacific Corporation Site located at 90 West Redwood Avenue in Fort Bragg, California. This change was requested by the Regional Water Quality Control Board (Water Board); however, the Board will continue to remain involved in the project and will act as the permitting authority for water-related issues.

In assuming lead on this site, DTSC will follow the Health and Safety Code (HSC) Chapter 6.8, State Superfund cleanup process for this Site. This cleanup process requires specific public participation activities, including conducting a community survey to define the level of community interest. Your response to the brief survey that is enclosed will enable DTSC to determine the level of community interest in this project, conduct appropriate community outreach activities, and involve the community during any required clean-up activities.

We are beginning the standard community involvement activities—beginning with this community survey—prior to issuing an Order for the Georgia Pacific site that will supersede the current Water Board Order. The Order will outline tasks and schedules for completing the investigation and any required cleanup plan for the Site. Prior to DTSC's approval of any draft cleanup plan, residents will receive a fact sheet summarizing the proposed cleanup activities and an announcement of a 30-day public comment period to review the documents. There may also be a community meeting to discuss the draft work plan.
